### Information Sheet for Prospective 2010 Yannadah Students

Please take time to read this information sheet as it will answer some of the most commonly asked questions.

#### APPLICATIONS

Main Round offers posted 20 January 2010 and applications **open on line from 21 January 2010**. Applications **close at 4.30 PM 29<sup>th</sup> January 2010** and successful applicants will be notified by phone/email commencing 2nd February 2009.

#### FEES AND CHARGES

To secure your place at Yannadah you must first pay a **\$225** room deposit **payable by 3.30 PM Friday 5th February 2010** refundable only if agreement is ongoing. Credit card payments can be made by phone (**02 9351 1622 & 02 9351 1662**) or by Cheque/Money Order.

This deposit is fully refundable at the end of your agreement after you have vacated your room and all is found to be in order. **Please take note that this deposit will be forfeited if the room is cancelled prior to the beginning of first semester.**

Incoming 2010 Yannadah residents can move into Yannadah the week prior to the start of semester (Start of Semester 1 - Monday 1st March 2010). The cost during this period will be \$160 per week or \$40.00 per night if you stay less than one week. There will be no catering service provided until the evening of Sunday 28<sup>th</sup> February 2010, students will need to cater for themselves during this period and are able to use the limited kitchen facilities available.

New residents will be required to nominate a date and time of arrival, **we require this notification no later than 19th February 2010** so that we can facilitate a smooth transition into Yannadah. With this information we are able to ensure you have access to the residence and car parking facilities for dropping off your belongings. Those students who have cars will have access to parking on campus but parking is restricted to the main car park with access through gate 2, there is also limited access to T Block car park. ***Please take particular note that strict parking restrictions apply so please familiarise yourself with all information relating to parking.***

You will be sent an information booklet via email, please acknowledge receipt of this information by return email to me by Friday 12th February 2010.
