

PURSUING AN INTEREST AND/OR A CAREER IN INTERNATIONAL LAW AND/OR INTERNATIONAL HUMAN RIGHTS LAW

Those of you who cultivate a particular interest in public/private international law and/or international human rights law may wish to consider the following opportunities available to you at the University of Sydney Faculty of Law and beyond.

TAKING COURSES WITH AN INTERNATIONAL/COMPARATIVE FOCUS

There are several elective subjects in the undergraduate and postgraduate program at the University of Sydney that allow students to pursue an interest in international law and politics in greater depth. Most electives are on a rolling program, so particular courses may not be offered every year. However, a glance at the handbook will acquaint you with those on offer in any one year. Undergraduates should plan your elective course load carefully in the final two years to ensure an opportunity to take those subjects in which you are most interested.

Furthermore, the Faculty offers a Masters of International Law, Masters of International Business Law, Masters of International Taxation, Graduate Diploma in International Law, and Graduate Diploma in International Business Law for both part-time and full-time postgraduate students. The Doctorate of Philosophy (PhD), Doctorate of Juridical Studies (SJD) and Masters of Laws (LLM) by Research programs within the Faculty also permit eligible students to pursue advanced study in the field of international law and/or international human rights law.

TAKING A CLINICAL COURSE (AT THE UNDERGRADUATE LEVEL)

If you identify an organisation in or near Sydney with which you would like to volunteer and you are an undergraduate student at the University of Sydney Faculty of Law, you might consider enrolling in a course that allows you to gain academic credit for the work that you do there. The undergraduate subject "Practising in the Public Interest" (Laws 3071), for example, enables students to gain credit for time spent working at an approved public interest site. Students wishing to enrol in this subject take the initiative to identify a public interest site at which they would like to work, subject to approval for purposes of the program. The Faculty will then support such students in arranging a volunteer placement at that site and in designing a project to be undertaken over the course of the semester at that site. Students are required to participate in an initial, five-day intensive course and a weekly seminar relating to issues arising and skills required in the practice of law in the public interest. Interested students should refer to the Law Faculty Handbook for further details.

The undergraduate "External Placement Program" (Laws 3025) similarly enables final-year undergraduate students to gain credit for volunteer work undertaken at an established public interest placement site, alongside which students undertake a research assignment and participate in a seminar allowing them to reflect upon their volunteer experience. Sites with which the Faculty has existing placement arrangements under this program include: Amnesty International (engaged with issues of international human rights law, international humanitarian law and related policy concerns), the Human Rights and Equal Opportunity Commission (concerned, in part, with the implementation and enforcement of international human rights law in Australia) and the Public Interest Advocacy Centre (undertaking research and advocacy work on international fair trade and human rights issues). UNDERTAKING VOLUNTEER WORK AND/OR PURSUING INTERNSHIP OPPORTUNITIES

Those of you who wish to gain a working knowledge of international law may wish to undertake volunteer work with organisations engaged with issues of international law and policy. You may, for example, consider contacting one of the following organisations in Sydney (or, in the case of ANZSIL, in Canberra) to determine their current volunteer needs:

In addition, a number of internship programs have been established and/or are under negotiation for Sydney University Faculty of Law students, enabling students to undertake work experience with Australian embassies abroad. Details of these opportunities and the relevant application process will be posted, as they arise, on the Careers Noticeboard on Level 4 in the Law School building and circulated to students who have previously expressed interest (via email to fleurj@law.usyd.edu.au).

Furthermore, from time to time, members of the Faculty engaged in academic research and writing in the international legal field may require research assistance on particular projects. Students interested in applying for such (paid) positions should keep an eye on noticeboards in the Faculty foyer or may contact members of the Faculty in advance to indicate their interest in such positions, should they arise.

Regarding opportunities outside Australia, most international organisations offer internship programs at their head offices around the world (most of these require self-funding, but not all). You might consider applying for an internship through one of these programs, with a view to taking up a position either during the holidays between academic years or after graduation.
