

Faculty of Engineering and Information Technologies Credit Agreement Scholarship

Terms and Conditions

March 2018

1. Description

- a. The Scholarship has been funded in 2017 by the Faculty of Engineering and Information Technologies to assist high achieving students who applied for admission via a formal credit recognition agreement, or other agreement which has been approved by the Dean as being recognised as permitting participating in this Scholarship.

2. Eligibility

- a. International students that have received an unconditional offer of admission to an eligible undergraduate course within the Faculty of Engineering and Information Technologies at the University of Sydney, and have a WAM of 75 (or equivalent) in their current studies.
- b. Applicants must have applied for admission to the Faculty through:
 - a. a formal credit recognition agreement that the Faculty, or one of its schools, has entered into with an overseas higher education partner institution which permits eligibility for this Scholarship, or
 - b. an alternative international agreement that has been recognised as permitting eligibility for this Scholarship, under the discretion of the Dean of the Faculty of Engineering and Information Technologies.
- c. Applicants must be enrolling into an eligible course(s) which will be stated in the scholarship advertising.

3. Selection

- a. The Scholarship will be awarded on the basis of prior tertiary academic merit.
- b. The Scholarship will be awarded on the recommendation of the selection committee, which will include the Faculty Associate Dean (Education) or their nominee, and the Head of School of each participating school within the Faculty, or their nominees.

4. Amount

- a. The Scholarship will provide an amount of \$5,000 per annum, which will be paid in two equal instalments after the census date of each semester.
- b. The Scholarship has a maximum duration of two years.
- c. The Scholarship is not deferrable and cannot be transferred to another undergraduate course outside a participating school in the Faculty of Engineering and Information Technologies.
- d. The Scholarship will be offered subject to funding availability.

5. Ongoing eligibility

- a. The recipient must maintain a WAM of 65 or more each semester.
- b. The recipient must have paid their University fees by the relevant due date for each teaching period.
- c. Recipients undertaking an approved exchange program during the tenure of this Scholarship are required to have achieved a Satisfied Requirements grade (SR) to receive their next payment.

6. Termination

- a. The Scholarship will be terminated if the recipient:
 - I. withdraws from an eligible course or fails to enrol,
 - II. has not paid their University fees by the relevant due date,
 - III. commences part-time study (anything less than 24 credit points per semester) without prior approval,
 - IV. does not maintain satisfactory academic performance,
 - V. is determined by the University to be guilty of serious misconduct, including, but not limited to, having provided false or misleading information as part of their Scholarship application,
 - VI. does not resume study at the end of a period of approved leave, or
 - VII. meets any other termination provision as indicated in these terms.
- b. Where a student is found guilty of serious misconduct the University reserves the right to request that any scholarship funds paid to the Scholarship recipient be reimbursed.
- c. If the Scholarship is terminated, it will not be reinstated.
