

# Dean's Undergraduate Scholarship in Business

The Dean's Undergraduate Scholarship in Business supports high achieving HSC students with a demonstrated interest in business.

## Scholarship value and duration

\$15,000 per year, tenable for a maximum 4 years (inclusive of honours)

## Eligibility criteria

- Open to Australian citizens or permanent residents commencing an undergraduate degree program at the University of Sydney Business School.
- If the recipient is undertaking a combined law degree the scholarship is only valid for the duration of the Business award course and honours year, if taken.
- Applicants must commence their studies in the year for which the offer is made. No deferment is allowed.

## Background

Established to support high achieving HSC students.

## Selection criteria

- Awarded on the basis of academic merit.
- Awarded to a student scoring a minimum ATAR (or equivalent) of 99.50 or above in the NSW Higher School Certificate (or approved equivalent) with outstanding achievements in public speaking, leadership and community achievement and a demonstrated interest in business.
- All offers of award are conditional upon evidence that the student meets the essential criteria.
- Each scholarship will be awarded at the discretion of the Dean of The University of Sydney Business School or the Dean's nominees.

## Ongoing eligibility

- Recipients must meet all program requirements and maintain an average grade of 75 Distinction.

## Payment schedule

- Payment will be made in two equal instalments after each census date for every year the scholarship is awarded.

## Dean's Undergraduate Scholarship in Business Terms and Conditions

The scholarship is awarded under the following conditions:

1. The name of each scholarship shall be the Deans nominees.
2. All offers of award are conditional upon evidence that the student meets the essential criteria.
3. A confirmed offer of a scholarship must be taken up by enrolment in the first year of the nominated degree in the year for which the offer is made. No scholarship may be deferred.
4. Each scholarship is tenable only at the University of Sydney Business School and for the recipients meeting all the regulations of the program and subject to academic progression at the Distinction grade level (75 Distinction average each semester). Deans single primary scholarship OR; if the candidate is the recipient of a University of Sydney Outstanding Achievement Scholarship, they may hold the Deans scholar will be paid in two equal installments, once in March and again in August each year, subject to the recipient remaining a fully enrolled student in the agreed degree program.
5. Each scholarship is guaranteed upon acceptance of enrolment but if the recipient discontinues the degree or leaves the University during the course of the year the Business School may require repayment of that year's stipend.
