

# SC0379 Marion Macaulay Bequest Scholarship

## Terms and Conditions

### 1. Background

- a. Established in 1995, the Miss Marion Macaulay Bequest has been bequeathed to the University of Sydney in order to assist students to achieve their educational potential in the area of humanities.
- b. The Marion Macaulay Bequest Scholarship will provide financial support to high-achieving undergraduate or postgraduate coursework students who are travelling overseas for approved exchange or professional experience.

### 2. Eligibility

- a. Applicants must be currently enrolled in an undergraduate or postgraduate course in the Sydney School of Education and Social Work, in the Faculty of Arts and Social Sciences at the University of Sydney.
- b. Applicants must be travelling overseas:
  - I. on an approved exchange to be credited towards their degree, or
  - II. for approved professional experience (e.g. internships or practicum) that is to be credited towards their degree.
- c. Applicants must not hold more than two awards from the bequest or another Exchange Scholarship from the University of Sydney.

### 3. Selection Criteria

- a. The Scholarship will be awarded on the basis of academic merit and a personal statement.
- b. The Scholarship will be awarded by a selection committee consisting of the Dean of Faculty of Arts and Social Sciences, or the Head of the School of Education and Social Work, or their nominee, and one other academic member of staff within the School.

### 4. Value

- a. The Scholarship will be valued at \$7,500 per annum and is tenable for one year.
- b. If the successful recipient already holds a primary scholarship then this Scholarship will be valued at \$5,000 per annum and will be tenable for one year.
- c. Payment will be made as a one off payment on receipt of proof of approved exchange or professional experience.
- d. The Scholarship is not deferrable or transferable to another purpose or degree program.
- e. No other amount is payable.
- f. The Scholarship will be offered subject to the availability of funds.

### 5. Ongoing eligibility

- a. Not applicable

### 6. Termination

- d. The Scholarship will be terminated if the recipient:
  - I. withdraws from an eligible program or fails to enrol,
  - II. commences part-time study without prior approval,
  - III. does not undertake the travel overseas for the purpose of the Scholarship in the approved timeframe,
  - IV. is determined by the University to be guilty of serious misconduct, including, but not limited to, having provided false or misleading information as part of their Scholarship application, and
  - V. any other provision as indicated in these terms that would lead to termination.
- e. The Scholarship will not be reinstated once it has been terminated.
- f. Where a student is found guilty of serious misconduct, or where they do not complete their internship in the required semester of completion, the University reserves the right to request that any Scholarship funds paid to the Scholarship recipient be reimbursed.
