- There is no separate application process. State high school students who apply for any University of Sydney scholarship for study in the Business School will automatically be considered for this award.

Background

Established in 2003 by a donation from Professor Wayne Lonergan.

Selection criteria

- The scholarship is awarded on the basis of academic merit, leadership skills, personal attributes and achievements.

Ongoing eligibility

- To retain the scholarship, the recipient will be required to maintain a 75 Distinction average grade each semester.
- Scholarship holders must remain enrolled in the standard full-time load of 24 credit points per semester. If extenuating circumstances arise scholarship holders may submit a request to decrease their loading to a minimum full time load of three units of study (18 credit points) per semester but only with the permission of the Business School. The duration of the scholarship will not be extended if a student undertakes a minimum full time load.
- Scholarship recipients must be enrolled full-time and in the agreed degree program during the tenure of their scholarship. Requests to hold the scholarship part-time will only be approved under exceptional circumstances such as a medical condition which limits the student's capacity to undertake full-time study. Such requests must be supported by the Dean.
- Each scholarship is offered for, and is tenable in, a specific degree program and is not transferable to another degree program, except with the permission of the Dean responsible for the initial program, and does not involve lengthening the tenure of the scholarship.
- A confirmed offer of a scholarship must be taken up by enrolment in the first year of the nominated degree program in the year for which the offer is made. No deferment of enrolment or Scholarship is allowed.

Payment schedule

- The scholarship will be paid in two instalments, late in March and late in August each year.

Wayne Lonergan Distinguished Undergraduate Scholarship Terms and Conditions

1. Established in 2003 by a donation from Professor Wayne Lonergan.
2. The scholarship is awarded annually to a local student from a State High School commencing a degree at undergraduate level with the University of Sydney Business School.
3. The scholarship is awarded on the basis of academic merit, leadership skills, personal attributes and achievements.
4. There is no separate application process. State high school students who apply for any University of Sydney scholarship for study in the Business School will automatically be considered for this award.
5. The award is valued at \$10,000 per year for a period of up to four years (honours year inclusive, if applicable) in full time enrolment with the Business School and subject to satisfactory performance. The scholarship will be paid in two instalments, late in March and late in August each year. To retain the scholarship, the recipient will be required to maintain a 75 Distinction average grade each semester.
6. Scholarship holders must remain enrolled in the standard full-time load of 24 credit points per semester. If extenuating circumstances arise scholarship holders may submit a request to decrease their loading to a minimum full time load of three units of study (18 credit points) per semester but only with the permission of the Business School. The duration of the scholarship will not be extended if a student undertakes a minimum full time load.
7. Scholarship recipients must be enrolled full-time and in the agreed degree program during the tenure of their scholarship. Requests to hold the scholarship part-time will only be approved under exceptional circumstances such as a medical condition which limits the student's capacity to undertake full-time study. Such requests must be supported by the Dean.
8. Each scholarship is offered for, and is tenable in, a specific degree program and is not transferable to another degree program, except with the permission of the Dean responsible for the initial program, and does not involve lengthening the tenure of the scholarship.
9. A confirmed offer of a scholarship must be taken up by enrolment in the first year of the nominated degree program in the year for which the offer is made. No deferment of enrolment or Scholarship is allowed.
10. The scholarship shall be terminated if the recipient:
fails to achieve an average mark of 75 in the agreed degree program each semester;
withdraws from the agreed degree program.
11. Once terminated the scholarship will not be reinstated.
