Postgraduate Coursework Start-Up Scholarship

This scholarship assists commencing postgraduate masters by coursework students with the costs of returning to tertiary study within the Faculty of Arts and Social Sciences at the University of Sydney.

Scholarship value and duration

\$5,000 paid as a one-off payment

Eligibility criteria

- Domestic students who have an unconditional offer of admission by the application closing date for any postgraduate masters by coursework program offered by Faculty of Arts and Social Sciences at the University of Sydney, for the relevant commencing semester, as stated in the Scholarship advertisement.
- Students who have commenced their postgraduate coursework studies within the Faculty are not eligible.
- Students with an unconditional offer to study part-time are eligible, providing they enrol in minimum of 12 credit points of study in their first semester of study.

Background

Established in 2017 and funded by the Faculty of Arts and Social Sciences (Faculty), this scholarship assists commencing postgraduate masters by coursework students with the costs of returning to tertiary study within the Faculty.

Up to 20 scholarships available.

Selection criteria

- Eligible students will automatically be considered and the Scholarship will be awarded based on students' previous tertiary academic results.

Payment schedule

- A single payment will be made after the census date of the semester the recipient commences their studies.
- Recipients must be enrolled in a Faculty of Arts and Social Sciences postgraduate masters by coursework program at the University of Sydney after the census date to receive payment.
- Student must also be enrolled in a minimum of 12 credit points of study in their commencing semester.
- Payment is subject to funding availability and the Scholarship cannot be transferred to another non-postgraduate masters by coursework program within the Faculty, another school, faculty, or university.
- Deferment of the Scholarship is not permitted.

Termination

- a. The Scholarship will be terminated on the following grounds:
 - i. The recipient fails to successfully enrol in their course for the semester in which the scholarship was offered,
 - ii. The recipient withdraws from their course prior to the census date,
 - iii. The recipient is not enrolled in their course after the census date,
 - iv. The recipient is not enrolled in a minimum of 12 credit points of study in their first semester, and
 - v. The recipient transfers to another non-postgraduate masters by coursework program within the Faculty or to another school, faculty or university.
- b. Once the Scholarship has been terminated, it will not be reinstated.
