

# The University of Sydney Inspired by Business Cadigal Scholarship

The University of Sydney Inspired by Business Cadigal Scholarship was established to recognise and support talented indigenous students to achieve their full potential.

## Scholarship value and duration

\$10,000 per year for 3 years.

## Eligibility criteria

- To be eligible for the Scholarship, applicants must be an Australian Citizen of Australian Aboriginal or Torres Strait Islander descent who have applied for entry through the University's Cadigal Program for an undergraduate program offered by the University of Sydney Business School.
- Candidates who have completed the NSW Higher School Certificate (HSC) or an approved equivalent secondary school examination in the year prior to commencing an undergraduate coursework degree at the University of Sydney Business School

## Background

Established in 2017, the University of Sydney Business School Inspired by Business Cadigal Scholarship aims to provide financial support to students of Australian Aboriginal and Torres Strait Islander descent. Three scholarships will be awarded annually for eligible students commencing a degree within the University of Sydney Business School and who apply through the Cadigal Pathway Program.

## Selection criteria

The Scholarship will be awarded on the basis of:

- I. Application to the Cadigal Program,
  - II. academic merit, and
  - III. leadership statement.
- b. Shortlisted applicants may be requested to attend an interview with the Selection Committee.

## Ongoing eligibility

- Continuation of the scholarship is dependent on the recipient meeting degree requirements and maintaining a grade average that is deemed satisfactory by the Business School each semester. Satisfactory progression for this award is deemed as a minimum PASS grade in each unit undertaken by the recipient.
- The recipient must be enrolled in a standard full-time semester load of 24 credit points each semester, in the agreed degree program, during the tenure of their scholarship. If extenuating circumstances arise, the recipient may submit a request to decrease their enrolment to a minimum full-time load of 18 credit points per semester but only with the permission of the University of Sydney Business School.
- A confirmed offer of a scholarship must be taken up by enrolment in the nominated program in the semester for which the offer is made. The scholarship cannot be deferred.

## The University of Sydney Inspired by Business Cadigal Scholarship

### Terms and Conditions 2017

#### 1. Background

- a. Established in 2017, the University of Sydney Business School Inspired by Business Cadigal Scholarship aims to provide financial support to students of Australian Aboriginal and Torres Strait Islander descent. Three scholarships will be awarded annually for eligible students commencing a degree within the University of Sydney Business School and who apply through the Cadigal Pathway Program.

#### 2. Eligibility

- a. To be eligible for the Scholarship, applicants must be an Australian Citizen of Australian Aboriginal or Torres Strait Islander descent who have applied for entry through the University's Cadigal Program for an undergraduate program offered by the University of Sydney Business School.
- b. Applicants must have completed their HSC studies or equivalent in the year prior to commencing their undergraduate studies in the University of Sydney Business School and have achieved an ATAR of 85 or equivalent.

#### 3. Selection Criteria

- a. The Scholarship will be awarded on the basis of:
  - I. Application to the Cadigal Program,
  - II. academic merit, and
  - III. leadership statement.
- b. Shortlisted applicants may be requested to attend an interview with the Selection Committee.
- c. The Scholarship will be awarded by a Selection Committee consisting of the relevant Associate Dean or nominee, a member of staff from the Cadigal Program and/or one other staff member from the University of Sydney Business School.

#### 4. Value

- a. The Scholarship is valued at \$10,000 per annum and is tenable for the duration of the recipient's undergraduate studies up to a maximum of four years full-time equivalent.
- b. The annual amount will be made in two equal instalments after the census date of each semester.
- c. Deferral of the Scholarship is not permitted without the prior permission of the relevant Associate Dean and it is not transferable to another school, faculty or university.
- d. The Scholarship will be offered subject to the availability of funds.
- e. No other amount is payable.

#### 5. Ongoing eligibility

- a. To continue receipt of the Scholarship, the recipient must maintain a minimum SAM of 50 each semester.
- b. Recipients must maintain a full-time enrolment of 24 credit points per semester during the tenure of the Scholarship. Recipients may decrease their study load for extenuating circumstances which limits the capacity of the student to study full-time, with the prior approval of the Faculty.

- c. Recipients undertaking an exchange during the tenure of this Scholarship are required to have achieved a Satisfied Requirements grade (SR) to receive their next payment.

## **6. Termination**

- a. The Scholarship will be terminated if the recipient:
  - I. withdraws from an eligible course or fails to enrol,
  - II. commences part-time study without prior approval,
  - III. does not maintain satisfactory academic performance,
  - IV. is determined by the University to be guilty of serious misconduct, including, but not limited to, having provided false or misleading information as part of their Scholarship application,
  - V. is awarded an alternative primary scholarship. In such circumstances this scholarship will be terminated in favour of the alternative scholarship where the alternative scholarship is of higher value,
  - VI. does not resume study at the end of a period of approved leave, or
  - VII. any other provision as indicated in these terms that would lead to termination.
- b. Once terminated, a scholarship will not be reinstated.
- c. Where a student is found guilty of serious misconduct or withdraws from the relevant course, the University reserves the right to request that any Scholarship funds paid to the Scholarship recipient be reimbursed.
