

International Immersion in Singapore Scholarship

Terms and Conditions

October 2017

1. Background

- a. Established in 2017, The International Immersion in Singapore Scholarship has been established to enrich the student experience and promote the international profile of the University of Sydney Business School's study abroad program.
- b. Students enrolled in the Unit of study BUSS9406 will have a unique opportunity to attend the National University of Singapore. Students will participate in a research project for two weeks to understand and analyse an important demographic trends that impact business, societies and markets.

2. Eligibility

- a. Applicants must be currently enrolled in an undergraduate program administered by the University of Sydney Business School and have completed a minimum of 48 credit points at the time of application.
- b. Applicants must be approved to enrol in BUSS9406 and to undertake the research program in Singapore.
- c. Applicants must have achieved a minimum Weighted Average Mark (WAM) of 70 during their undergraduate studies in the University of Sydney Business School and be able to demonstrate leadership potential, problems solving acuity and the ability work with within a diverse group.

3. Selection Criteria

- a. The Scholarship specifically will be awarded on the basis of academic merit, their application for the research program in Singapore and a personal statement demonstrating their leadership potential, problem solving acuity and ability to work within a diverse group.
- b. The Scholarship will be awarded on the recommendation of a selection committee which will be appointed by the Deputy Dean of the University of Sydney Business School each year.

4. Value

- a. The Scholarship is valued at \$3,000 as a one off payment.
- b. The Scholarship value will be paid prior to the commencement of the recipients' BUSS9406 Program.
- c. Deferral of the Scholarship is not permitted without the prior permission of the Associate Dean and it is not transferable to another, school, faculty or university.
- d. The Scholarship will be offered subject to the availability of funds.
- e. No other amount is payable.

5. Ongoing eligibility

- a. To continue receipt of the Scholarship, the recipient must maintain their enrolment in BUSS9406 for the semester of the award.

6. Termination

- a. The Scholarship will be terminated if the recipient:
 - I. withdraws from an eligible course or fails to enrol,
 - II. withdraw from BUSS9406 or fails to complete all assessments of the unit of study,
 - III. fails to obtain a visa or entry into Singapore,
 - IV. commences part-time study without prior approval,
 - V. does not maintain satisfactory academic performance,
 - VI. is determined by the University to be guilty of serious misconduct, including, but not limited to, having provided false or misleading information as part of their Scholarship application,
 - VII. does not resume study at the end of a period of approved leave,
 - VIII. if the recipient receives an alternative primary scholarship. In such circumstances this Scholarship will be terminated in favour of the alternative scholarship where it is of higher value, or
 - IX. any other provision as indicated in these terms that would lead to termination.
- b. Once terminated the Scholarship will not be reinstated.
- c. Where a student is found guilty of serious misconduct or withdraws from the relevant course, the University reserves the right to request that any Scholarship funds paid to the Scholarship recipient be reimbursed.
