ARCHITECTURE INDIGENOUS LEADERSHIP SCHOLARSHIP

- a) The name of the Scholarship shall be the "Architecture Leadership Scholarship". The objective of the scholarship is to facilitate structured learning to advance the scholarship recipient's growth as an architecture practitioner and leader consistent with the aims and objectives of the Architecture Leadership Program and in accordance with University's rules and policies as are made and amended from time to time.
- b) The name of the Scholarship shall be the "Architecture Leadership Scholarship". The objective of the scholarship is to facilitate structured learning to advance the scholarship recipient's growth as an architecture practitioner and leader consistent with the aims and objectives of the Architecture Leadership Program and in accordance with University's rules and policies as are made and amended from time to time.
- c) The scholarship shall be open to all prospective students of Aboriginal and Torres Strait Islander background who qualify to enter the Bachelor of Design in Architecture or Bachelor of Architecture and Environments in the Faculty of Architecture, Design and Planning. Students enrolling in combined degree programs are not eligible.
- d) There shall be no bonding or other commitment with regard to employment with the Donor following graduation.
- e) The recipient of the scholarship will hold no other primary scholarship, but may accept from time to time such one off scholarships and prizes as may be eligible/awarded for academic merit.
- f) The scholarship cannot be deferred.

2. Tenure

- a) The recipient must enrol full-time in the agreed program during the tenure of the their scholarship;
- b) The recipient must meet all the requirements of the Architecture Leadership Program;
- c) The recipient must meet the required AAM of 65; and
- d) The recipient must not hold another scholarship of equal or higher value.

3. Awarding of the Scholarship

The scholarship shall be awarded, at the Dean's (or delegate's) discretion based on an assessment of:

a) Academic merit as indicated by the applicant's performance in the NSW HSC examination or equivalent for their preferred program (Bachelor of Design in Architecture or Bachelor of Architecture and Environments) and above a minimum level determined as acceptable by the Faculty of Architecture, Design and Planning. In the event that a scholarship place is replaced during the course of the scholarship duration, the replacement will be chosen on the basis of academic performance at University and performance at the NSW HSC examination or equivalent as deemed acceptable by the Faculty of Architecture, Design and Planning.

- b) Demonstrated interpersonal skills, leadership qualities, communication skills, creativity, innovation and self-motivation.
- c) Demonstrated achievements in non-academic ventures and involvement in school and community ventures

4. Practical Experience

A scholar shall, at the conclusion of each academic year and in order to satisfy the requirements for the award of a degree and/or specified units of study, or equivalent as amended from time to time, undertake practical work experience with the Donor or an organisation mutually agreed between the University and Donor (for example a charity).

It is anticipated that the practical work experience schedule will be as follows:

- -- At the end of Year 1: 8 weeks between December and February
- At the end of Year 2: 10 weeks between December and February

It is intended that work experience gained will significantly benefit the scholarship recipient in achieving the goals of the scholarship and the Leadership Program.

5. Report of the Scholar

At the conclusion of a scholar's practical experience placement each year, the scholar shall prepare a report on their industrial experience and shall submit the report to the Faculty of Architecture, Design and Planning for review and assessment.

6. Value and Payments

- a) The scholarship shall be valued at \$18,000 per annum. The annual work experience component is unpaid.
- b) The scholarship will be paid to the scholar in two instalments each year. This will normally be the first \$9,000 after 31 March and the second \$9,000 after 31 August, Census dates of each semester. These payments will be administered by the Faculty of Architecture, Design and Planning.
