### II) Low Socio-Economic Status

Please provide as much documentary evidence as possible that shows your experience with financial hardships.

#### This must include:

- Bank account statement with transaction history of your everyday account, for at least the past 30 days
- Bank account statements for all financial accounts and investment accounts you hold
- Any documents that show upcoming financial responsibilities (e.g. bills, invoices, quotes, upcoming loan repayments or item instalments)

#### This may include:

- Proof of Centrelink (if applicable).
- Any documentation that documents your registration with and/or reception of any governmental, charity, or non-governmental social assistance payments

If this scholarship criteria applies to you, please **briefly** elaborate in your personal statement on your experience with financial hardships. If you are unable to provide sufficient documentation, please also outline your circumstances/ why you do not have access to this.

### III) Long-term medical condition/disability (including ongoing effects of abuse)

Please provide documentary evidence that shows your experience with a long-term medical condition/disability

### This may include:

- -Doctor's letters/letters of diagnoses
- -Any documentation that shows your long-term experience with this condition/disability

If this scholarship criteria applies to you, please **briefly** elaborate in your personal statement on your experience with long-term medical conditions and/or disabilities. If

you are unable to provide sufficient documentation, please also outline your circumstances/ why you do not have access to this.

## IV) Carer responsibilities:

- -Any documentation that shows your dependant's disability and your obligations as a carer
