<b>English requirements</b>	<a href="https://www.sydney.edu.au/study/english-regs">sydney.edu.au/study/english-regs</a> English requirement may be met by satisfactory achievement in at least one year of full-time study in a recognised bachelor's degree where instruction (teaching, assessment & examination) was entirely in English, provided that the studies were undertaken within five years of commencing the Sydney course and approved by the University.

- Credit will be offered as part of the application for admission. A separate application for credit is not required (select **NO** to the credit application).
