COURSE REQUIREMENTS

A master's degree requires the completion of 48 credit points, while a graduate diploma requires 24 credit points. Unless otherwise specified, each unit of study is worth 6 credit points. Part-time students may enrol in up to 12 credit points per semester. Full-time students must enrol in at least 18 credit points but no more than 24 credit points per semester. Student visa holders are required to enrol in 24 credit points per semester. Award requirements of individual courses are published in the [Sydney University of Sydney Handbook](#).

ATTENDANCE REQUIREMENTS

All scheduled classes, learning activities, and supervised assessments (including tests and exams) are held in person on the university campus. Access to classes and reading materials is granted only to students who are formally enrolled in the relevant unit. Students are required to attend a minimum of 70% of classes. For intensive units, students are expected to attend 100% of classes. Please refer to the attendance requirements in the relevant [unit outline](#). Failure to meet the attendance requirement will result in an "Absent Fail" (AF) grade.

Publication of Grades

Grades for all postgraduate law units, including early intensive units, are published in Sydney Student at the end of the semester, around mid-July for Semester 1 and mid-December for Semester 2. Please refer to the [Guides to grades](#) for more information.

Assessments for late intensive units may take place later in the semester, and grades might be released after the official university date. Unit coordinators will announce the expected grade release date via Canvas. Final assessments for intensive units are generally due within 4 to 6 weeks from the last class date. Please consider these late submission dates and marking periods when planning your studies, graduation, student visas, and personal or work commitments. Enrolling in earlier intensive units might be necessary. The actual assessment due dates will be published in your [unit outline](#), which is available about 2 weeks before the first class.
